RULES AND REGULATION

ELIGIBILITY:

This contest is intended for residents of Canada only, (excluding Quebec) and will be interpreted according to Canadian Law. No purchase is necessary. Limit of three (3) photo submissions per person. Submissions accepted on **Monday, May 1st, 2017** until 11:59pm on June 16th, 2017. Theme of photos must depict what Canada means to you. Photo(s) must be taken by the entrant in Canada between January 1st, 2016 and June 16th, 2017. Photographs must be real images taken by digital or standard camera and submitted online only. Standard camera images may be scanned and uploaded to the contest website. Content of images must not be altered, manipulated or adjusted. Photo must be taken by the entrant and be their sole work. Third party stock library photos or professional photographer images are not eligible. Photographs that are illegal, defamatory or obscene as determined by the Contest sponsor in its sole discretion will not be eligible to be displayed. Photographs which have been published or publicly exhibited outside of this contest are not eligible to win. Photo entries will become the property of the contest sponsor.
